- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The programs have been granted accreditation for three years. Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill-Bheemaram, Mandal, Hasanparthy, Andhra Pradesh-506015 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a visit, as deemed appropriate by NBA Committees.
- 5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Kakatiya Institute of Technology & Science, Yerragattu Hillock, Vill-Bheemaram, Mandal, Hasanparthy, Andhra Pradesh- 506015 as a whole.
