The following are suggested by the Hon'ble Members and come up for discussion.

i. The Principal updated the visit of Sri V.Indraneel, Executive Director, KITS(S) to the Institute on 2<sup>nd</sup> March, 2023. He attended the Chairman Sir's interaction with ECE Faculty. Participating in the interaction, Mr.Indraneel spoke on the importance of Industry Connect. He advised that the department faculty should pro-actively establish direct Industry connect with the help of T&P Section. This helps for core placements to students and designing industry relevant curriculum. He further advised faculty to spend good time with Industry for up-skilling on current technology & tools. The Administrative Committee advised the Principal to work out on a policy for faculty interaction with Industry.

- ii. Hon'ble members of the committee expressed their concern about the decrease in filling of the seats in some of the UG and PG courses. Due to non-filling of seats in few of the courses in UG Programmes Sri V.Satish Kumar, Hon'ble *MLA and Hon'ble member* suggested to fill the 'B' Category seats with NRIs. Hon'ble Treasurer Sri P. Narayana Reddy garu suggested that it is required to know the payment of Tuition Fee in Dollars. Hon'ble Chairman Sir instructed the Principal to know the procedure from the Principal of CBIT, Hyderabad in filling 'B' category seats with NRIs.
- iii. Construction of Over head Water Tank in the campus/on Block –IV for drinking water purpose. Hon'ble Chairman advised to place the item in the next meeting.
- iv. Regarding the Item No. 04 the Hon'ble members have raised some clarification regarding the implementation of policy whether it restricted to Hanumakonda or any other place in the country. It is clarified that the policy will be implemented wherever the incident takes place within India.
